Memorandum of Understanding

Whereas, the Parties above collectively as members of the joint holding company known as the American Ukraine Green Energy and Telecommunications Holding Company LLC agree together to combine and confederate towards the implementation of a number of major industrial / Infrastructure and Commercial Transactions Projects;

Wherefore, the above parties hereby agreed to share proprietary secret, confidential, classified, and / or other private information, contacts, resources, facilities, operation on modus operandi and / or other instrumentalities which are proprietary or valuable to the parties themselves equally or in combination therein.;

Wherefore, the parties above are agreeable with information sharing as referenced above, hereby agreed not to circumvent directly or indirectly or nor to disclose directly or indirectly any of the information submitted to each other, or gained by each other during the course of their business activities together;

Consequently, the parties further agreed to abide by all International norms' customs, thus norms customs protocol and procedures during their interaction with each other, using the highest level of ethical standards and implementing the greatest confidentiality associated with all information, resources, and other valuable proprietary and / or confidential data;

Whereas, the parties further agreed to abide by the international Chamber of Commerce (last revision series 600 and others), in addition to the standardized International and money laundering protocols established by BASEL one two, and three in case of interbank transactions or other financial activities;

Whereas, the parties here and further agreed to implement their best efforts and execute their highest degree of attention to the international aspect of establishing private inter banking relationships between each other, or with other institutions, banks, and organizations, in addition to the implementation of Special Purpose Vehicles (SPV - offshore company registered entity) and / or other facilities necessary to establish legal, clean and clear interbank relationships between the parties herein, as the primary basis for this agreement, and additional agreements specific to the furtherance of the above necessary facilities including but not limited to bank accounts, establish Special Purpose Vehicle companies in private tax domicile countries, which are not on black or grey list categories, using only A+ rated banks, and top countries where possible, in addition of the purpose of this agreement, is to support and substantiate, as well as formalize the additional underlying agreements for implementation of bank accounts, Special Purpose Vehicles and other inter Bank facilities and resources for the benefit of the parties in accordance with all domestic and international rules, regulations, treaties, and laws;

Whereas, the Parties further agree to implement their commercial transactions agreements and contracts at the highest level of professional ethics and protocol, organizing initial contracts and engagement agreements for each separate transaction covered by this general memorandum of understanding to further the implementation of the said projects;

Whereas the Projects under this MOU are as follows:

- The Green Clean Solar Co Generation Utility Scale Electricity Plant at the ChNPP
 Special Exclusion Zone in Ukraine whereby this area is granted for access and usage
 rights- permissions and authorizations as required to realize the aspirations of this and
 other projects within the ChNPP Special Exclusion Zone by the Authorities who are
 responsible for such permission authorization and access this project awarding
 Enerkon Solar International (ENKS OTC) as the main lead EPC Contractor and
 Consortium/Financial Manager;
- 2. The 5G National Telecommunications Network under UKRDORSVYAZ and its director Ryazantsev Anatoli the state entity charged with administration of such projects in combination with the partners of the American Ukraine Green Energy and Telecommunication Holding Company this project awarding Enerkon Solar International (ENKS OTC) new Technology Division who will invite major EPC partners CISCO, Nokia and Ericson for terrestrial networks and SpaceX for Space based Satellite constellation support and launch facilities for the new Satellite Project of the State of Ukraine for which Diplomatic Trade Ltd and ENKS are supporting with Official meetings support and protocol support as well as implementation supervision and in the case of the land based networks , as the main lead EPC Contractor and Consortium/Financial Manager;
- 3. The Ukraine Hydrogen Electrolysis Plant facility to built on the ChNPP Special Exclusion Zone taking power from the Solar array as well as the CO generation Plant and producing tonnage of Green Hydrogen for sale to the EU companies who have already pre-ordered production offtake from the facility with this project awarding Enerkon Solar International (ENKS OTC) new Technologies Division as the main lead EPC Contractor and Consortium/Financial Manager;
- 4. The Titanium Production modernization program joint venture for investment, mining support, purchase and sales of Titanium Ore and initially Fabricated materials this in partnership with Maven (Saudi Arabia a partner of Alcoa and Khosei in Tokyo, Japan all producers of Titanium and investors in the Titanium industry this project awarding Enerkon Solar International (ENKS OTC) New Technologies Division as the main lead and Consortium/Financial Manager;]

Whereas, all of the above projects shall be administered as one collection under the umbrella of the American Ukraine Green Energy and Telecommunication Holdings LLC;

Whereas, each project shall have its own operational agreement with obligations and responsibilities set out in the agreements clearly and all particulars revised and ratified by the

Whereas, The parties to this MOU further agree that the Funding and Financial obligations for these projects are available and will be provided by and through the Enerkon Solar International and its divisions as well as Diplomatic Trade Ltd and others including but not limited to the ECO World Alliance for which through the Office of Dr Mohamed Zayed PhD are supporting the Projects of the Ukraine Government as to Infrastructure by and through Diplomatic Trade Ltd and others with the supervision of their chairman Mr. James Fierro – The Eco World Alliance are not part of this MOU nor Part of any contracts or agreements with the Holding Company herein but rather financial supporters of the National Government whereby these PPP Projects shall be supported with EPC partners (CISCO Erickson Nokia and others) as well as funding and capacity support;

Whereas, the Venue in case of litigation is the United States Federal District Court in Wyoming USA – and/or the International Arbitration Association as first choice of the parties in case of any dispute pursuant to this MOU or underlaying agreements;

Whereas, the Term of this agreement shall be 15 years with option to extend in case of PPA or other contracts extending past 15 years in any of the above projects that may affects rights or obligations or other equity and valuable considerations between the parties;

Responsibilities of the parties shall be clear at all times and addendum and annex may be drafted and signed in writing only – whereby the same shall become a part of the entire agreement and memorandum or understanding between the Parties herein.

Wherefore, the parties undersigned as signed by their hand today, hereby agree to the foregoing in totality, without protest or recourse, and the same is hereby irrevocably agreed on this 27th day of February 2021.
