Dear Mr. Ballout,

Joint Stock Company "Ukrenergomontazh" is one of the most advanced construction and installation companies in Ukraine, engaged in the implementation of energy projects both on the Ukrainian market and abroad.

Our main advantage is the unique highly qualified personnel with many years of experience in implementing the most complex projects with a non-standard approach to their implementation. We are very familiar with the Chernobyl nuclear power plant and the Exclusion Zone around it. The results of our work are highly appreciated and awarded by the government of Ukraine and our numerous foreign partners.

Our company is engaged in design, project management, equipment supply, installation, as well as its commissioning.

The company begins its history in 1972, the period of the beginning of the construction of the Chernobyl nuclear power plant, where it was engaged in the manufacture and installation of metal structures and technological equipment from the 1st to the 6th power units of the nuclear power plant.

During the disaster at the 4th power unit of the Chernobyl nuclear power plant, the company's personnel took an active part in eliminating the accident, which gave the subsequent basis for gaining knowledge on radioactive waste management and solving non-standard tasks during the implementation of construction projects.

During the period from 1987 to 2000, the company participated in the construction of energy, residential and industrial construction projects. The company's portfolio includes objects related to the construction, installation and commissioning of objects: in Moscow, Russia and many objects in Ukraine as Slavutich; South Ukrainian and Rivne NPP; Kremenchug, Burshtynskaya, Kiev Thermo Energy Central Power Plant as so forth.

The newest history of the company begins in 2000, when, on the basis of the "Memorandum of Understanding between the Government of Ukraine and the G7 countries" (1995), Ukraine undertakes to decommission the Chernobyl NPP power units ahead of schedule and adopt the "Action Plan for the Shelter" ", (a dome over the destroyed blocks), (1997). Since 2000, the company has been one of the leaders in the construction and commissioning of infrastructure facilities associated with the removal of the Chernobyl nuclear power plant from the grid using the program to transform the Shelter into an ecologically safe area.

To our significant protection projects:

- The new industrial heating boiler house was put into commercial operation, which meets the needs of the ChNPP industrial site in hot water and steam;
- Storage facility for spent nuclear fuel ISF-2 (construction was carried out at the expense of the European Bank of Reconstruction & Development funding; general contractor - firm "FROMATOM");
- Industrial complex for the management of solid radioactive waste (PCOTRO): construction was carried out at the expense of the European Commission and the contribution of Ukraine; general contractor - Nukem firm;
- Plant for the processing of liquid radioactive waste (LRWTP): construction was carried out at the expense of the European Bank of Reconstruction & Development funding; the general contractor is "Belgat".
- Stabilization measures at the Shelter: construction was carried out at the expense of the European Bank of Reconstruction & Development funding; general contractor is UTEM;
- Installation of a new ventilation pipe for the 3rd and 4th power units of the Chernobyl NPP: construction was carried out at the expense of the European Bank of Reconstruction & Development funding; general contractor Ukrenergomontazh;
- construction of a fire protection system for the Shelter: the construction was carried out at the expense of the European Bank of Reconstruction & Development funding; general contractor Ukrenergomontazh;
- construction of the enclosing contour of the New Safe Confinement of the 2nd stage of the Chernobyl NPP: construction was carried out at the expense of the European Bank of Reconstruction & Development funding; general contractor Ukrenergomontazh.

During the period of recent history, the company participated in the construction of the 1st power unit of the Bushehr NPP in the Islamic country of Iran, where it installed technological pipelines and equipment, and carried out electrical work.


Currently, the company is the main contractor for the construction of the Centralized Storage Facility for Nuclear Waste Fuel of Ukrainian NPPs, which is being implemented on the territory of the ChNPP Exclusion Zone.

Today we decided to follow the global trend of replacing thermal and nuclear energy with alternative energy and we are now actively working in this direction. We learned that your company applied to the Chernobyl NPP, the Ministry of Ecology of Ukraine and the Ukrainian government with a proposal for technical and financial partnerships for the

construction of power generating facilities, incl. for the production of solar energy. We are opened to such dialogue from our side and we are ready to accompany such projects and assist in their advancement together with you on the territory of the Chernobyl nuclear power plant and the Exclusion Zone.
